Funding

If your child is receiving a funded place in the Nursery it is important that these sessions are regularly attended. If your child is absent for a session can you please phone the school office on 01726 882646 or e-mail grsecretary@stpiranscross.co.uk.If you are taking a holiday during term time can you please obtain a request for leave form from the website or school office. Your child will be authorised to take term time holiday. The funding agency audit the school and if children are not attending the sessions on a regular basis the school will be forced to withdraw the sessions. You will be notified of any withdrawal by letter.

Consent for local walks, sport (including swimming), music and drama events

Periodically the children will be included in sporting events or the class may wish to walk outside the perimeter of the school for local studies. With exception of walks to the nearby park, you will always be informed of such activities before they take place. However, to save asking for individual consent on each occasion we ask you to sign this annual consent form.

Data and images

Following the Data Protection Act of 1998, the personal data that we have has to be securely held on the school computer system. We have to register and comply with a number of regulations issued by the Information Commissioner. All of the information you provide is of course completely confidential.

We regularly take digital photos of the children as evidence of their learning and progress; these are displayed and held internally. Occasionally, children may be photographed or filmed for external purposes such as for the school website, newspapers and other media. We love to celebrate the school and children’s achievements in this way, but please indicate if you are not happy for your child to feature in such photos or filming.

The law states that private citizens are able to take photos and video footage for their own personal record, and as such we are happy for you to take photos and video at school events. We ask that you do not upload these photos or videos to social networking sites such as YouTube and Facebook as you contravene the wishes of other parents by doing this. No photos or video should be taken during swimming.

Medical Information

We update our records regarding children’s medical conditions annually. Please provide details of any medical conditions your child may have. Children with detailed medical problems will already have had their information passed to their new class teacher.

Any medical conditions we should be aware of e.g. asthma, diabetes, allergies e.g. to plasters, needs to wear glasses etc. **If none please state none**

Bike Helmets

We have a variety of bikes in the Nursery for the children to ride. If you would like them to wear a helmet when riding, please provide one clearly named and ensure that it is the correct fit for your child.

Sun Cream

On sunny days please apply sun cream to your child before they start their nursery session. If they stay all day and may need to have more on, please supply this in a clearly named bottle. It would help if your child has learnt to apply this themselves.

Acceptable Use Policy - Rules for using IT equipment and the Internet

- I will ask a teacher or suitable adult if I want to use the computers or other devices
- I will only use activities that a teacher or suitable adult has told or allowed me to use
- I will take care of all equipment
- I will ask for help from a teacher or suitable adult if I am not sure what to do or if I think I have done something wrong
- I will not access other people’s files
- I will tell a teacher or suitable adult if I see something that upsets me on the screen
- I know that if I break the rules I might not be allowed to use the IT equipment
