This remissions policy sets out the circumstances in which charges will be waived. Criteria for qualification for remission are given to parents in receipt of:*

- *Income Support;*
- *Income-based Jobseekers Allowance;*
- *Support under part VI of the Immigration and Asylum Act 1999;*
- *Child Tax Credit, provided the parent is not entitled to Working Tax Credit [and the family's income (as assessed by Her Majesty's Revenue and Customs) does not exceed £16,190*
- *the guaranteed element of State Pension Credit;*
- *Income related employment and support allowance; and*
- *Universal credit in prescribed circumstances*


